2. Repair and restore paving systems.	a. Damaged, loose, or uneven pavers are identified and replaced or reset to restore the paving system.		
	b. Trip hazards are remediated and evenness or permeability is restored.		
	c. Jointing materials are replenished and edge restraints are checked for integrity.

#### Assessment specifications:

*Streetscape paving* refers to the design, selection, and installation of different paving materials in public spaces such as sidewalks, plazas, pedestrian zones, parks, and road edges. The focus is on durability, safety, aesthetics, and functionality to make these areas accessible and attractive.

To achieve this standard, the candidate must maintain and repair streetscape paving in line with industry standards.

*Industry standards* must reflect best practice, workplace procedures, and be within acceptable tolerances as defined in New Zealand codes, standards and regulations.

Evidence for this standard must be:

- to current and relevant legislation, standards, and codes (including safety),
- in an environmentally sustainable manner,
- within an acceptable timeframe,
- in different and unfamiliar contexts,
- with acceptable behaviours.

#### Ihirangi waitohu | Indicative content

- Routine cleaning methods: sweeping, water blasting, steam cleaning
- Organic growth and efflorescence removal techniques
- Maintenance of permeable paving: unclogging joints, restoring infiltration
- Replacing or resetting pavers: methods, tools, and safety
- Joint sand top-up and edge restraint checks
- Environmentally safe cleaning agents and tools (e.g. propane weed burner)
- Sealing options: solvent-based, water-based, penetrating vs. film-forming
- Impacts of UV, moisture, and traffic on paver durability
- Maintenance record-keeping and scheduling
- Adapting maintenance practices for different climates and uses
