Whāinga Aim	This micro-credential addresses a skill gap in Aotearoa New Zealand by providing formal training for those who work with edge protection. The purpose of this micro-credential is to provide a formal credential to recognise the skills and knowledge required for the selection, installation and removal of temporary edge protection. It is for those who work unsupervised, applying risk assessment, working safely at heights, and completing the maintenance of edge protection systems used by the construction and maintenance sector.

Putanga Outcome

On successful completion of this micro-credential, learners/ākonga will be able to use edge protection systems for the prevention of falls from height.

Learners/ākonga will have knowledge of the different types of temporary edge protection systems.

Learners/ākonga will be skilled in ensuring compliance with safety standards and regulations to prevent falls and enhance site safety, and using, maintaining, inspecting and handing over edge protection systems to prevent falls from height.

Paeuru Entry

Providers must ensure learners/ākonga have access to a workplace that can provide learning support through mentors, verifiers, or supervisors who have expertise working in Edge Protection.

It is highly recommended that unit standards 6402 Provide basic life support; 6401 Provide first aid and 6400 Manage first aid in an emergency situation are completed before entering this micro-credential.

Learners/ākonga must have access to a workplace for training and assessment. The provider may be able to assist with work placement for those not already employed.

Learners/ākonga must have access to an edge protection worksite to meet the work-based learning component of this micro-credential.

Learners/ākonga require sufficient literacy capability for reading and completing workplace documents.

Providers will support learners/ākonga during delivery to ensure they have the level of language proficiency required.
